## Landscape Committee Update



**Asphalt Path** - Now complete! Reminder surface will harden in the summer months as it gets hotter outside.

**AK Lawn Care** - Three year agreement signed (March 2024-March 2027)

**Pond Maintenance** - Washtenaw County Drain inspector, David Streeter, is obtaining bids to improve pond drainage. Work to potentially be paid for by the county & estimated for late summer. Hoping for a dry summer!

**Goats** - Yes, goats! Engagement and Landscape Committees are partnering with a local vendor to use goats to reduce growth around ponds.

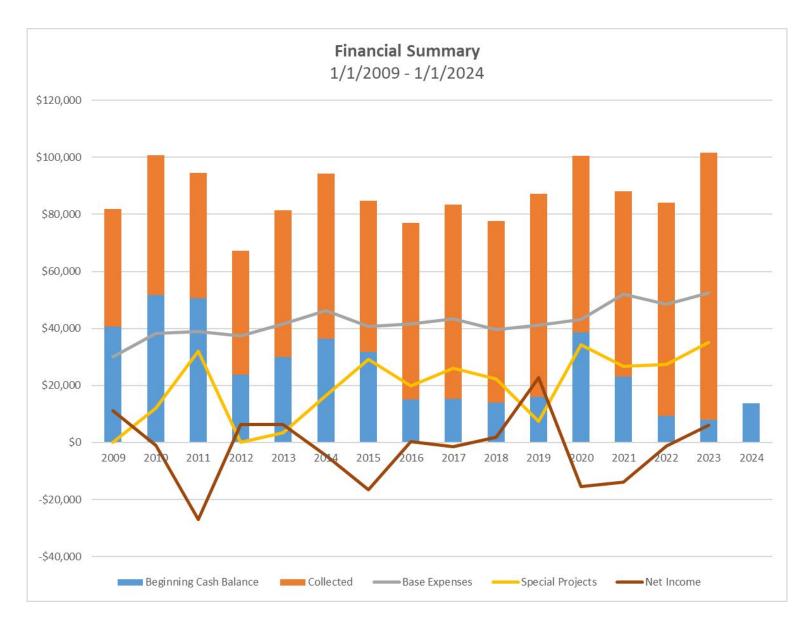
